F. TERMS AND CONDITIONS

1. ACCOMMODATION

Accommodation is always quoted in double rooms with private facilities. For single rooms a single supplement fee will be applicable. Triple rooms or family suites can be booked upon request, if hotels have availability. If you are traveling alone and need a roommate, we will try to suggest a suitable roommate. If there is no suitable person, single supplement will apply.

2. MEALS

Two meals per day included in tour price (breakfast and dinner).

3. FLIGHTS

Please note that Airlines have the right to change flight schedules and we as tour operators have no control over this. In case of sudden changes, we will do everything in our power to change the land arrangements. If new times have an influence on the itinerary, we cannot be kept liable for any discomfort due to this unforeseen happening.

4. TRANSPORT

All land transport included. Additional taxi's (for instance after a day program ended) will be for your own account.

5. BREAKAWAY OPTIONS

Please inform WEGO Journeys if you intend to do add-on tours or flight breakaways.

6. POLITICAL INSTABILITY

In the case of political instability and any possibility of tour members being in danger, the itinerary will be amended accordingly.

7. PASSPORTS AND VISAS

South African citizens do not need a visa for travel to Israel. Passport expiry date must be more than 60 days after tour return date.

8. EXCLUDED FROM THE TOUR

- Travel and medical insurance
- Single supplement costs
- Lunch expenses
- Land arrangements e.g. train tickets / bus tickets / day tours. We can assist.

9. IMPORTANT NOTES

- DEPOSIT needed to secure booking. Deposit can be transferred before airline tickets are issued.
- FINAL PRICE is determined by the exchange rate on date of payment deadline.
- LUGGAGE as per airline regulations. Normally 23 kg per person check in and 7 kg hand luggage.
- CANCELLATION after payment deadlines will result in no refund policy and you will have to claim from your travel insurance (we will assist you).
- In the case of accommodation cancellation from the supplier's side, we will make bookings in the same class hotels as indicated per itinerary.

G. STATEMENT

No deposits are refundable if I would cancel after payment date as set out in the terms of payment. If WEGO Journeys cancelled the tour, the full deposit is refundable.
